HHS Announces More Than \$65 Million to Address the Maternal Health Crisis and Invest in New Approaches to Care

Black and American Indian/Alaska Native women are two to three times more likely to die of pregnancy-related causes than White women. To address this disparity, the U.S. Department of Health and Human Services (HHS), through the Health Resources and Services Administration (HRSA), awarded funding to 35 HRSAsupported health centers.

The health centers will tailor their services to the communities they serve and develop patient-centered care delivery models. Examples of innovate approaches include offering bilingual doula services, leveraging health technology to reach rural patients, and providing culturally aware mental and behavioral health care for pregnant women and their families.

AMA, IHI Launch Nationwide Equity Coalition In Health Care

The American Medical Association (AMA), the Institute for Healthcare Improvement (IHI), and Race Forward launched "<u>Rise to Health: A National Coalition for Equity in Health Care."</u> The coalition will work across health care organizations to advance racial justice and eliminate inequities in health care. The coalition's goals are to mobilize individuals and health care organizations to create action as well as to shift culture and practices.

July Observances: World Hepatitis Day (July 28), BIPOC Mental Health Month

The theme for this year's Hepatitis Day observation is <u>We're Not Waiting</u> and the World Hepatitis Alliance offers <u>campaign</u> <u>materials</u> in multiple languages.

Rural and Urban Differences in Factors Associated with Inpatient Hospital Stays for Substance Use Disorder



This policy brief finds

that rural inpatients were nine times more likely than others to reside in areas with no buprenorphine waivered physicians and are more likely to be admitted to inpatient stays via court or law enforcement.

The authors discuss the need for better data standards and sharing, updates to the OMB standards to accurately reflect the demographics of the population, and incorporating interoperability resources into measure specifications that can help promote the reliable sharing of race and ethnicity data.

CMS Shares Resources Addressing the Needs of Adults with Intellectual & Developmental Disabilities and Their Caregiver

Experts are forecasting increases in the number of adults with intellectual and developmental disabilities living at home with aging caregivers. The Centers for Medicare & Medicaid Services shared resources to assist state Medicaid and partner agencies to address the needs of adults with I/ DD living with and supported by aging parents and other caregivers.

Opportunities to Enhance Health Equity by Integrating Community Health Workers into Payment and Care Delivery Reforms

This reports discusses the role of community health workers in improving equitable access to care and outlines several types of roles they can play e.g., providing direct services, acting as cultural mediators, conducting outreach, and building community capacity. The report outlines learnings from the COVID-19 testing strategies that can be mapped to a health equity framework that utilizes community health workers.
