CMS' Inaugural Health Equity Conference - RECAP

CMS held its first health equity conference at Howard University in Washington, D.C. on June 7th and 8th. Several hundred people attended in person and about 3000 attended virtually, marking a successful two day event. The plenary sessions featured speakers from several HHS agencies highlighting their commitment and successes in promoting health equity. Breakout sessions focused on innovative initiatives and best practices to address health disparities from health care organizations, community-based organizations, associations, and policymakers. A tip for implementing culturally and linguistically appropriate services

HHS National CLAS Standards – [Standard 3](#)

Recruit, promote, and support a culturally and linguistically diverse governance, leadership, and workforce that are responsive to the populations in the service area.

- Target recruitment efforts to the populations being served to increase the recruitment of culturally and linguistically diverse individuals. Racial and ethnic parity between clinicians and staff, and their patients improves communications, builds trust, reduces adverse events, and results in better health outcomes.

The [Americans with Disabilities Act](#) was passed July 26, 1990. To honor this landmark legislation, Disability Pride Month is celebrated each July to acknowledge the experiences, achievements, and challenges of people with disabilities.

[Possibility Shop Assists Rural Maryland Residents](#)

The Possibility Shop in Maryland’s rural Allegany County connects vulnerable populations to health and human services and resources such as hygiene products, food, clothing, housing, and care management services. The program, which is staffed by community health workers and peer recovery specialists, has 13 partners including insurance navigators, health organizations, food banks, and other agencies. The results of the program are impressive: from January through May 2023, 2,983 service encounters occurred and 253 intakes to services were performed.

[Rural Outreach Center in Rural Western New York](#)

The Rural Outreach Center (ROC) offers care coordination, therapy, budgeting assistance, and a variety of other services to individuals and families living in poverty in rural Western New York. The program serves approximately 250 adults and children each year through counseling, care coordination, and empowerment opportunities to help individuals break free of generational poverty. To address transportation barriers, which can limit access to services for rural residents, the ROC partners with the Volunteer Transportation Center and offers gas cards based on individual needs.

[Advancing Equity for AA & NH/PI Communities](#)

The HHS Office of Minority Health has released a series of resources that offer best practices to advance cultural competency, language access, and affirming care for Asian American, Native Hawaiian, and Pacific Islander (AA and NH/PI) communities in COVID-19 response efforts. The guides were developed based on a Request for Information, literature searches, and listening sessions with leaders from the AA and NH/PI communities. The series includes introductory, language access, community engagement and data disaggregation resource guides.

[Joint Commission Health Care Equity Certification](#)

The Joint Commission released an on-demand webinar that provides an in-depth review of the new health care equity certification standards and elements of performance, examples of how they can be applied, and available resources. This voluntary certification program, effective July 1, 2023, will be available to hospitals and critical access hospitals “already on their journey to health care equity and would like to formalize structures, processes, and goals for identifying and addressing health disparities.” The webinar is approved for 1 Continuing Education Credit through July 24th.
